JUDGMENT

The petitioner is the Manager of S.N.L.P. School, Vettikattiri, an aided school. The third respondent is the Full Time Arabic teacher. The petitioner suspended the third respondent. The initial period of 15 days was affirmed by the second respondent. Thereafter, the second respondent refused to extend the suspension period. Exts.P6 and P8 are the orders. Aggrieved by these orders, the petitioner has approached the Government by Ext.P9 Revision Petition. The petitioner has also filed Ext.P10 stay application.

In view of the limited request made before this Court, there shall be a direction to the first respondent to consider and pass appropriate orders on Ext.P9 after hearing the petitioner and the third respondent within a period of three

months. In the meanwhile, the stay application application moved by the petitioner shall also be taken up within ten days from the date of receipt of a copy of this judgment.

The writ petition is disposed of as above.
