Ext. P4 notice to show cause as to why the petitioners shall not be disqualified from being a member of the Managing Committee has been responded to by Ext. P5 objection. The grievance of the petitioners is that the copy of the complaint dated 18.01.2015 received in this regard as well as the enquiry report dated 30.01.2015 of the Dairy Extension Officer has not been made available.
