JUDGMENT

Petitioner was appointed as Upper Primary School Assistant in the 5th respondent school as per Ext.P1 from 01.06.2010 to 31.03.2013. This appointment was rejected by Exts.P2 and P3. Thereafter, petitioner was appointed in a promotion vacancy from 01.06.2011 onwards and this appointment was approved. The only dispute is relating to the period mentioned in Ext.P1 from 01.06.2010 to 31.03.2013. Petitioner approached the Government in revision. Ext.P6 is the memorandum of revision.

2. In view of pendency of Ext.P6, there shall be a direction to the first respondent to consider and dispose of Ext.P6 after affording an opportunity of hearing to the petitioner and 5th respondent Manager within a period of four months from the date of receipt of a copy of this judgment.
