JUDGMENT

The petitioner has approached this Court with the following prayers:

i. Issue a writ in the nature of mandamus or any other writs, orders or directions directing the District Collector, Thrissur, the 1st respondent, to consider Ext.P11 application sent by the petitioner and take immediate decisions regarding the prayers made therein as expeditiously as possible and within a time bound manner, that may be fixed by this Hon'ble Court.

2. Heard the learned Government Pleader as well.

3. Considering the limited extent of relief sought for, this Court does not find it necessary to adjudicate the issue on merits.

4. After hearing both the sides, the writ petition is disposed of, directing the first respondent/District Collector to consider and pass appropriate orders on Ext.P11 application preferred by the petitioner, after giving an opportunity of hearing to the petitioner and other interested parties, as expeditiously as possible, at the earliest, at any rate, within 'four weeks' from the date of receipt of a copy of this judgment.
