JUDGMENT

The petitioners, who are members of the 4th respondent Co-operative Society, have filed this writ petition seeking a writ of certiorari to quash Ext.P2 and seeking a writ of mandamus commanding the respondents to permit them to vote in the election to the Managing Committee of the 4th respondent Society scheduled to be held on 7.4.2013.

Though the writ petition was filed on 15.3.2013, the petitioners could not obtain any interim order. Since the election to the Managing Committee of the 4th respondent Society has already been held on 7.4.2013, no relief can be granted at this point of time. As such this writ petition is dismissed. But the contentions raised in the writ petition are left open.
