Heard the learned counsel for the petitioner and the learned Government Pleader.

2. This writ petition has been filed by the petitioner alleging that his father was harassed by the police and suffered injuries, on account of which, he is undergoing treatment.

3. Learned Government Pleader submits that a crime was registered against the petitioner's father, in which, he was taken into judicial custody and thereafter granted bail on the next day. It is submitted that bail conditions have not been complied with by the petitioner's father and steps are being taken by the police authorities.

4. Learned counsel for the petitioner submits that a direction may be issued to respondents 1 and 2 to take appropriate action on Exts.P6 and P7 representations submitted by the petitioner and to give compensation for harassment.

We are not inclined to entertain the writ petition at the instance of the petitioner, especially when, a crime has been registered against the petitioner's father and he has already been granted bail and the allegation against the petitioner's father is that he has not complied with the bail conditions.
