- ii. To issue a writ of mandamus or any other appropriate writ, order or direction to respondents 1 and 4 to ensure conduct of election by participation of parents regulated by identity cards issued till 27.1.2015 within such time fixed by this Hon'ble Court.
- iii. Such other reliefs which this Hon'ble Court may deem fit and proper in the interest of justice."
