JUDGMENT

The petitioner confines his relief to easy instalments to pay the amount demanded. I permit the petitioner to pay the amount due in four equal monthly instalments. The instalments shall be paid on or before the 10th of every month starting from 10.07.2015.

2. The respondent shall issue a revised bill to the petitioner within a period of two weeks. The coercive steps pursuant to Exts.P11 and P12 shall be put on hold if the petitioner complies with the conditions in time. The coercive steps shall surge ahead if the petitioner commits default in the payment of any one of the instalments.

The Writ Petition is disposed of.
