JUDGMENT

The petitioner approached the 2nd respondent by Ext.P6 pointing out certain anomalies in the promotion effected to the post of Cashier from the feeder category post of Office Attendant Grade- I. Petitioner submits that the 4th respondent is not qualified to be promoted as a cashier. The petitioner, therefore, submits that he is entitled to promotion as a cashier.

2. Considering the fact that the petitioner already highlighted his grievance by Ext.P6, I am of the view that appropriate decision shall be taken by the 2nd respondent after hearing the petitioner and the 4th respondent, within a period of six weeks from the date of receipt of a copy of this judgment.

The petitioner shall also produce a copy of the writ petition along with this judgment before the 2nd respondent for compliance. The writ petition is disposed of as above.
