JUDGMENT

Petitioners retired from service of Kerala Agricultural University. They all approached this Court for disbursal of pensionary benefits. Except the 7th petitioner, all other petitioners claimed that they were not paid DCRG and Computation. However, the 7th respondent only seeks pay revision arrears.

2. Learned Standing Counsel appearing for the University submits that due to some financial constraints, they are unable to disburse the amount. They seek one year time to pay the entire amount due to the petitioners.

3. Considering the facts and circumstances, the University is directed to pay the entire amount within six months from the date of receipt of a copy of this judgment. If the University fails to pay the amount in time, it will carry an interest at 6% from the date of default.

The writ petition is disposed of accordingly.
