JUDGMENT

The petitioner approached the Government on account of non-approval of the period of his service. The above period is stated as follows:

2. Ext.P14 is the consolidated revision petition before the Government. The petitioner seeks an early disposal of Ext.P14.

3. The learned Government Pleader points out that certain approval was rejected in the years 2002 and 2006 and the petitioner has not chosen to challenge those rejection and therefore, the petitioner's claim for approval has become

stale. It is also stated that the consolidated revision petition is also not maintainable.

I am of the view, these are all matters to be adverted by the Government while considering Ext.P14. Therefore, there shall be a direction to the first respondent to consider Ext.P14 after hearing the petitioner and the Manager within a period of four months.
