JUDGMENT

Shaffique, J

Petitioner has approached this Court seeking for police protection alleging that respondents 4 to 16 were obstructing the functioning of the unit run by the petitioner.

2. Interim order has already been passed by this Court on 26.2.2014 by which the police was directed to ensure proper ingress and egress to the petitioner's unit and maintain law and order.

3. Learned Government Pleader submits that during the pendency of the writ petition, no untoward incident has been reported.

Hence, we close the writ petition with liberty to the petitioner to approach the police if there is any further cause of action.
