JUDGMENT

The petitioner approached the first respondent by Ext.P10 Revision Petition. The grievance of the petitioner is that even though the Director of Public Instructions has passed Ext.P9 order to include her in the teachers package, no action has been taken by the Assistant Educational Officer, Tripunithura to implement Ext.P9 order. The petitioner submits that even though she was directed to be included in the teachers package, the Director of Public Instructions while passing the order, did not order payment of salary from December, 2013 onwards.

In view of the pendency of the above, an appropriate decision shall be taken by the first respondent on Ext.P10 in respect of the salary claimed by the petitioner from December, 2013 onwards within a period of four months after hearing the petitioner.

The writ petition is disposed of as above.
