JUDGMENT

The petitioner is appointed as HSA with effect from 4.6.2012 in an additional post created during 2006-2007. The authorities rejected the approval. However, the Director of Public Instructions has approved the appointment with effect from 4.6.2012 to 31.3.2013 on daily wage basis and thereafter, on regular scale of pay from 3.6.2013 onwards. The petitioner aggrieved by his approval on daily wages with effect from 4.6.2012 to 31.3.2013, has approached the first respondent by Ext.P3 Revision Petition.

In view of the above, there shall be a direction to the first respondent to consider and pass appropriate orders on Ext.P3 within a period of four months.

The writ petition is disposed of as above.
