JUDGMENT

The petitioner was promoted as HSA (Maths) with effect from 8.10.2012 in Kadachira High School against the regular permanent vacancy of Sri.M.Sreenish who was promoted as HSST. The petitioner submits that she is entitled for regular scale of pay from the date of appointment. However, the appointment was approved from 8.10.2012 to 31.3.2013 on daily wages. Aggrieved by the above, the petitioner has approached the Government by Ext.P5 revision. The only limited request made before this Court is for an early disposal of Ext.P5.

In view of the above, there shall be a direction to the second respondent to dispose Ext.P5 after affording an opportunity of hearing to the petitioner within a period of three months.

The writ petition is disposed of as above.
