JUDGMENT

The petitioner is concerned with the seizure of the vehicle for an offence alleged under the Kerala Minor Mineral Concession Rules, 1967. The petitioner was granted release of the vehicle on payment of Rs.25,000/-. Going by the decisions in ***Digil V.Sub Inspector of Police [2013 (1) KLT 600]*** and ***Sivakumar V. State of Kerala and Another [2013 KHC 2757]***, the petitioner shall be allowed compounding if Rs.25,000/- has been paid and no further proceedings shall be taken against the petitioner.

The writ petition is allowed.
