JUDGMENT

The delay in providing electricity connection to the residential villa of the petitioner is complained of. The Kerala State Electricity Board points out that they have moved the Additional District Magistrate, Ernakulam on 07.02.2015 in terms of Section 16 of the Indian Telegraph Act. This is in the wake of the objection raised by the fourth respondent as regards the drawing of electricity line.

2. I therefore direct the Additional District Magistrate, Ernakulam to take the proceedings to a logical end with notice to the petitioner. The needful shall be done within a period of one month from the date of receipt of a copy of this judgment.

The writ petition is disposed of.
