JUDGMENT

Ashok Bhushan, Ag, CJ.

Heard learned counsel for the petitioners and the learned Government Pleader. No notice is being issued to the first respondent, in view of the order, which is being passed.

2. The petitioners have filed this Writ Petition alleging police harassment. It is submitted that the petitioners have been called several times and asked to wait in the Police Station, which is nothing but harassment.

3. The learned Government Pleader, on instruction, submitted that two complaints were received in the Police Station forwarded from the Superintendent of Police and Deputy Superintendent of Police, Exhibits P9 and P11. It is submitted that the petitioners were called in connection with the complaints and after enquiry the Police

authorities have already submitted a report that the dispute is of civil nature and the complaints have been closed.

We do not think that it is a case of any police harassment. The Writ Petition is closed.
