J U D G M E N T

The petitioners have approached this Court seeking a direction to the Kerala Public Service Commission, regarding the availability of vacancies.

2. This Court, as per interim order dated 24.04.2012, directed the 2nd respondent to report the subsisting vacancies of Electricity Worker/Mazdoor in KSEB, Alappuzha District, to reach the 4th respondent on or before 30.04.2012.

3. Today, when the matter came up for hearing, the learned counsel for the petitioners submitted that the writ petition could be closed directing the Kerala Public Service Commission to fill up the vacancies if the vacancies have been reported.

Therefore, the writ petition is closed, directing the Kerala Public Service Commission to advice the candidates from Ext.P1 ranked list against the reported vacancies if the vacancies have already been reported.
