JUDGMENT

Only a weather proof wire of length 3 metres along the boundary of the property of the petitioner is being drawn to provide electricity connection to the fourth respondent. The alternate route suggested crosses the property of two others and is circuitous necessitating an overhead line of length 40 metres.

2. All the necessary inputs have been taken into consideration by the third respondent in according sanction in terms of Section 16 of the Indian Telegraph Act. I am not inclined to hold that Ext.P3 order passed by the third respondent is in any way vitiated warranting interference in this writ jurisdiction.

The Writ Petition fails and is dismissed.
