J U D G M E N T

The petitioner claims to be the legal heir of late Kali.K., who was a sanitation worker (full time contingent employee) of the Manjeri Municipality. Kali died on 90.5.2014 while in service. The petitioner submits she is entitled for compassionate appointment. As per Ext.P8, petitioner's application was rejected by the 2nd respondent stating that she cannot be considered for compassionate employment, as she is the married sister of the deceased. Accordingly the petitioner approached the Government by Ext.P11. The petitioner approached this Court seeking for a direction to the 1st respondent to consider Ext.P11 representation expeditiously.

2. Heard the learned counsel for the petitioner and the learned Senior Government Pleader.

3. Considering the above, there shall be a direction to the 1st respondent to consider and pass appropriate

orders on Ext.P11 within a period of three months after affording an opportunity of hearing the petitioner and the 2nd respondent.

The writ petition is disposed of as above.
