The petitioner is working as Overseer (Electrical) in Sankaracharya University. Pointing out salary anomalies, the petitioner approached the University. The petitioner submits that in terms of Section 14 (2) J of the Sankaracharya University Act, the University syndicate has power to ventilate the grievance of the petitioner.
