JUDGMENT

Shaffique, J.

Petitioner has approached this Court seeking police protection. It is, inter alia, contended that respondents 5 to 16 and their men are causing threat to the life of the petitioner. On 26-02-2015, the petitioner was attacked by the persons engaged by respondents 5 to 16 and she was hospitalized. Though complaints were preferred, no action has been taken by the police in the matter.

2. Learned State Attorney, on instructions, submitted that the petitioner is at loggerheads with her husband in the matter relating to property and she is also having complaints against her husbands' relatives as well as her relatives, who are arrayed as respondents 5 to 16.

3. It is contended that the husband of the petitioner

also had filed a complaint against the petitioner. The matter was inquired into by the police and for the time being, there is no threat or danger to the life of the petitioner, as contended by her.

Having regard to the submission of the learned State Attorney, we do not think that any direction as prayed for by the petitioner, is to be ordered in this Writ Petition. However, we observe that, if there is any threat or any offence being committed or attempt to commit offence, it is open for the petitioner to approach the police and the police shall do the needful.

With the above observation, this Writ Petition is closed.
