**JUDGMENT**

**Ashok Bhushan, C.J.**

This writ petition has been filed by the petitioner seeking a direction to respondent Nos.2 and 3 to afford adequate police protection to the life of the petitioner and his employees, protection to the properties and smooth functioning of the petitioner's business under the name and style M/s.Krishna Granites and Marbles.

2. Learned Senior Government Pleader submits that an interim order was passed by this Court on 04.04.2013 and as on date no untoward incident has been reported to the police. It is further submitted that a crime has already been registered as Crime N. 877 of 2013 in Ollur Police Station.

In the above view of the matter, we close the writ petition reserving the right of the petitioner to submit a complaint before the police authorities as and when there is any further cause of action.
