The complaint is that the sample signatures collected were not sent for comparison. Presently, it has been reported by the Sub Inspector of Police, Aluva East Police Station that the sample signatures along with admitted signatures were sought to be forwarded through the court below to the Finger Print Bureau (Hand Writing Expert Wing), Thiruvananthapuram for examination.
