Petitioner has approached this Court seeking for a direction to the respondent to regularise her appointment with effect from 30.7.1984 based on Ext. P1. It is submitted that though a representation was given as Ext. P2 and the Corporation had issued Ext. P3 dated 3.12.2010 indicating that appropriate orders would be passed within a short time, no action has been taken in the matter.

2. Learned counsel for the Corporation submits that the matter has been enquired into and it is noticed that her appointment had been regularized by judgment of this Court with effect from 1.9.1986.

Under such circumstances, there will be a direction to the respondent to pass appropriate orders within a period of one month from the date of receipt of a copy of this judgment.
