JUDGMENT

The petitioner submits that the 5th respondent-Manager harassed her and she is under suspension from 1.6.2013 by the Manager. Ext.P1 is the order passed by the second respondent ordering reinstatement. Thereafter, the first respondent stayed the order passed by the second respondent at the instance of the 5th respondent-Manager. The petitioner raised her objection before the first respondent. The petitioner has enumerated many grievances by Exts.P3 to P6 before the Government. The only limited request made before this Court is for an early consideration of Exts.P3 to P6 representations.

Considering the facts and circumstances as above, there shall be a direction to the first respondent to consider and

pass appropriate orders on Exts.P3 to P6 after affording an opportunity of hearing to the petitioner and respondents 5 to 8 within a period of three months.

The writ petition is disposed of as above.
