JUDGMENT

Being aggrieved of Ext.P2 order dated 17.02.2014 passed by the second respondent, the petitioner has already moved the first respondent by way of Ext.P3 appeal. A notice of hearing was issued by the 1st respondent vide Ext.P4. But the matter is still to be finalized and hence the writ petition.

2. Heard the learned Government Pleader as well.

After hearing both the sides, the writ petition is disposed of, directing the 1st respondent to pass final orders on Ext.P2 appeal in accordance with law, after affording an opportunity of hearing to the petitioner and other interested parties, if any, at the earliest at any rate within 'two months' from the date of receipt of a copy of this judgment. If the appeal has already been finalized by the 1st respondent, a copy of the order shall be communicated to the petitioner without further delay.

The petitioner shall produce a copy of the judgment along with a copy of the writ petition before the 1st respondent for further steps.
