**JUDGMENT**

Heard learned counsel for the petitioners and learned Government Pleader.

2. The petitioners by this writ petition pray for a mandamus directing the respondents not to harass or torture the petitioners. Petitioners claim that their marriage has been solemnized on 09.02.2015.

3. Learned Government Pleader submits that there is a complaint regarding man missing against the 2<sup>nd</sup> petitioner. Learned counsel for the petitioners submits that petitioners are ready to appear before the police so also before the Magistrate concerned to get their statement recorded.

In the above view of the matter, we see no case of police harassment in the matter. In the event the petitioners appear before the 3<sup>rd</sup> respondent, the 3<sup>rd</sup>
