JUDGMENT

Being aggrieved by Ext.P13 order passed by the third respondent dated 10.2.2015, the petitioner has already moved the first respondent by filing Ext.P14 revision petition. The limited relief sought for in this writ petition is to direct the first respondent to consider Ext.P14 within a reasonable time.

2. Heard the learned Government Pleader as well.

3. In view of the limited extent of relief sought for and proposed to be given, this Court does not find it necessary to deal with the merits of the case.

4. After hearing both the sides, there will be a direction to the first respondent to consider and pass appropriate orders on Ext.P14 in accordance with law, after affording an opportunity of hearing to the petitioner, at the earliest, at any rate, within 'two weeks' from the date of receipt of a copy of this judgment.

The petitioner shall produce a copy of the judgment, along

with a copy of the writ petition, before the first respondent, for further steps.

'Status quo' shall be maintained till such time.
