Shaffique, J

Petitioner has approached this Court seeking police protection in the matter relating to loading and unloading work carried on by the petitioner in his business establishment. According to the petitioner, he has his own registered permanent workers with identity cards under Rule 26A of the Head Load Workers Rules. The allegation is that respondents 3 to 8 were obstructing the loading and unloading work.

2. An interim order had already been passed by this Court on 18/03/2014.

3. Learned counsel for the petitioner submits that, on account of the interim order, no untoward incident has occurred.

Hence we close this writ petition with liberty to the petitioner to approach the police, if there is any further cause of action.
