JUDGMENT

The limited prayer in the writ petition is for a direction to the respondent to consider and pass orders on Ext.P2 representation of the petitioner for endorsement of tax, on the basis that the vehicle is a non transport vehicle, in the registration certificate for the period from 01.05.2013.

2. I have heard Sri.K.V.Gopinathan Nair, the learned counsel for the petitioner and Smt.Sobha Annamma Eappen, the learned Government Pleader for the respondent.

On a consideration of the facts and circumstances of the case and the submissions made across the Bar, I direct the respondent to consider and pass orders on Ext.P2 representation filed by the petitioner before him, within a period of one month from the date of receipt of a copy of this judgment, after hearing the petitioner.
