JUDGMENT

The petitioner challenges the staff fixation order of the 4th respondent. The 2nd respondent-Director of Public Instructions rejected the petitioner's claim by Ext.P10. Thereafter, petitioner moved the Government by filing Ext.P12 revision. The petitioner seeks a direction for an early disposal of Ext.P12 and also seeks a direction to retain her in the post of Physical Education Teacher till Ext.P12 is disposed of by the Government. The petitioner submits that she is continuing in the post of Physical Education Teacher in St.Thomas High School, Ayroor for the year 28 years.

2. Considering the above facts and circumstances, there shall be a direction to the first respondent to consider and dispose Ext.P12 within a period of three months from the date of receipt of a copy of this judgment, after affording an opportunity of hearing to the petitioner. Status quo shall be maintained for three more months from today.

The writ petition is disposed of as above.
