JUDGMENT

Petitioners are working as University Assistants in Kannur University. They were included in the rank list published by the University of Kannur for the appointment of Assistants. Petitioners submit that they were appointed on daily wage basis during the pendency of the list. Petitioner points out that more than 210 vacancies of Assistants exists in Kannur University. However, petitioners have not been regularized in spite of their inclusion in the rank list. Petitioners also have moved the Chancellor of the University by Ext.P5 representation.

2. In the light of pendency of Ext.P5 before the Chancellor of University, I am of the view, Chancellor will consider the petitioners grievances after hearing the petitioners and officials of the University.

The Writ Petition is disposed of.
