J U D G M E N T

The petitioner has two fold request before this Court in this writ petition. The first is for availing the benefit of 'One Time Settlement' facility as per the Circular No.2/2015 and second is for consideration of Ext.P8 representation submitted by him before the 1st respondent against the future tax on account of the fact that, the petitioner has dismantled the vehicle.

2. In respect of the first prayer, the alleged due is after 01.10.2011. Therefore, the petitioner is not entitled for the benefit as per the terms of Circular No.2/2015.
