The election has also to be conducted after pruning the voters list as required under Rule 18A of the Rules aforesaid.

2. The second respondent shall see to it that the voters list is accordingly prepared and steps taken to conduct the election of Cheppad Service Co-operative Bank Ltd. It shall be ensured that a new Managing Committee assumes office within a period of six months from today.
