The petitioner submits that his father died on 24.11.1991 while working as Science teacher in the 5th respondent school. The petitioner submits that he became major in the year 1994 and he made application within time under compassionate scheme before the 5th respondent. The petitioner now submits that the vacancy of Clerk is likely to be created in Higher Secondary Schools due to allocation of new pattern and therefore, he is eligible to be appointed.
