JUDGMENT

The petitioners are owners in possession of flat No.FF 24-226, in Block No.VIII in survey No.219/pt of Pallichal village, Thiruvananthapuram district, as allotted by the Kerala State Housing Board, Thiruvananthapuram. The grievance of the petitioners is that, regular water supply is not provided to the flat of the petitioners, though the flat was allotted on 14.8.2009.

2. The learned Counsel appearing for the second respondent submitted that, necessary works for providing water connection to the flat belonging to the petitioners are going on, and that the entire work would be completed within a period of one month. The submission made by the learned Counsel for the second respondent is recorded. There will be a direction to the second respondent to complete all the necessary works in order to provide water connection to the flat belonging to

the petitioners within a period of one month.

The writ petition is allowed as above.
