2. I direct the second respondent to consider Ext.P4 application in terms of Section 87(1)(c) of the Motor Vehicles Act, 1988. The needful shall be done with notice to the petitioner within a period of two weeks from the date of receipt of a copy of this judgment.

3. The petitioner shall be permitted to operate the stage carriage service on the basis of Ext.P1 regular permit as extended till such time.
