J U D G M E N T

The petitioners are contract carriage permit holders plying their autorikshaws in Perinthalmanna. Though the petitioner applied for variation of permit by Exts.P1 to P11, the respondent till not considered such applications till date. The petitioner produced a judgment of this Court in WP(C) No.31443/2014. This Court has in Rajesh v. Secretary, RTA [2014 (3) KLT 341], held that such general orders cannot be passed by the RTA and each application has to be considered individually and a reasoned order passed under Section 80(2) of The Kerala Motor Vehicles Act, 1988. In such circumstances, the application filed by the petitioners shall be accepted to the files of the RTA, Malappuram, and the same shall be considered within a period
