However, salary has not been disbursed for the reason that salary payable to one Sreenish T.V. in the rank list was subject matter of the dispute on account of non sanctioning of the post. The above dispute is subject matter in W.P.(C) No.9504/2014.

2. Today this Court in W.P.(C) No. 9509/2014 held that the first petitioner (Sreenish T.V.)in that case is entitled for approval. In view of the declaration that the first petitioner in that case is entitled for approval, these writ petitions are disposed of directing the respondents to disburse the salary from the date of the appointment without delay.

3. Needful shall be done to pay the salary and arrears of salary within three months from the date of receipt of a copy of this judgment.
