J U D G M E N T

The petitioner is a 4th year B.Pharm student, who has been consistently appearing for the second year supplementary examinations without any result. The petitioner seeks permission to appear for the 4th year examinations scheduled on 23.03.2015.

2. I have heard the learned Standing Counsel also.

3. As per the regulation of the University, only students qualified in the earlier years would be entitled to sit for the 4th year examinations. The petitioner had appeared for the March 2014 second year supplementary examinations, which he did not qualify. A further supplementary examination held also was participated it but, again without qualifying in the same. The petitioner

seeks that pending scheduling of another supplementary examination, he may be permitted to appear for the 4th year examination. No such relief can be considered.

The writ petition would stand dismissed.
