J U D G M E N T

The petitioner, who had availed of a loan from the respondent company and defaulted in repayment of the same, has approached this Court aggrieved by the steps taken by the respondent bank for recovery of the loan amounts. In the writ petition, the prayer of the petitioner is to permit her to pay the defaulted amounts in installments so as to regularise the loan.
