Petitioner was appointed as Physical Education Teacher in High School, Ramamangalam, an aided school situated in Muvattupuzha as per Ext.P1. Ext.P1 was rejected by the District Educational Officer as per Ext.P2. Assailing Ext.P2, the petitioner filed a statutory revision before the 1st respondent as per Ext.P6. The limited prayer of the petitioner is for an early disposal of Ext.P6 revision by the 1st respondent .
