JUDGMENT

The petitioners had filed the above writ petition to challenge Exhibit P8 series of notices for eviction, dated 06.03.2008 and for a mandamus to carry on rehabilitation of the petitioners in the vicinity itself.

2. The writ petition itself was filed against the eviction notices and no interim orders were passed. On 23.05.2008, the learned counsel for the petitioners had submitted that there is a contempt case pending, numbered as Cont. Case (C).No.321 of 2008, and the above writ petition be posted after the said case is disposed of. The contempt case is seen disposed of on 23.10.2009, finding that the judgment was complied with. In such circumstance, nothing survives in the writ petition and the same is dismissed. No costs.
