2. I direct the second respondent to consider Ext. P4 application in terms of Section 87(1)(c) of the Motor Vehicles Act, 1988. The needful shall be done with notice to the petitioner within a period of two weeks from the date of receipt of a copy of this judgment.

3. The petitioner shall be permitted to operate the stage carriage service on the basis of Ext. P1 regular permit as extended till such time.
