The petitioners have approached this Court with the following prayers:

"a. to issue a writ in the nature of mandamus or any other appropriate writ, order or direction commanding the first and 2nd respondents to issue Haj Pilgrim acknowledgement receipt based on Exts. P5 to P7 and include their name in the list for draw lot to be conducted on 21.03.2015 by the 1st and 2nd respondent.

b. to issue a writ in the nature of mandamus or any other appropriate writ, order or direction commanding the first respondent to consider Ext.P5 to 7 application in reserve category B in accordance with law and practice;

c. to grant such other relief as may be deemed just and proper."

2. The learned Government Pleader, on instruction submits that the petitioners' name have already been included in the list for lot and on drawing the lot, the petitioners came to be
