J U D G M E N T

The petitioner approached the Government alleging misuse of official power by the Additional Tahsildar (Mr. M. Najeeb), Chirayinkeezhu Taluk. Ext.P10 is the representation of the petitioner.

2. The Government directed the Land Revenue Commissioner to take appropriate action on Ext.P10. This is reflected from Ext.P12.

3. Considering the facts and circumstances, this Court is of the view that there shall be a finality to the enquiry by the 2nd respondent within 3 months after hearing the petitioner as well as Mr. Najeeb. The decision thereon shall be communicated to the petitioner without any delay.
