**JUDGMENT**

The petitioner is aggrieved with Ext.P9 order, which has been challenged in a revision before the Government by Ext.P10 revision. The petitioner contends that the seniority issue was agitated before this Court earlier and settled by Ext.P6 judgment. Pursuant to which, favourable orders were issued by the Government as per Ext.P8. However, again by Ext.P9, the Manager interfered with the directions in Ext.P8, which has now necessitated a revision, which is produced at Ext.P10. Considering the confined prayer made for expeditious disposal of Ext.P10, it is directed that the first respondent would consider Ext.P10 revision in a time bound manner, expeditiously within a period of four months from the date of receipt of a certified copy of this judgment. It is made clear that the Manager and any other

affected Teacher in the Corporate Management shall also be heard before Ext.P10 is disposed of.

The writ petition is disposed of.
