J U D G M E N T

The petitioner is under suspension pending disciplinary proceedings. Ext.P5 is the order of suspension. It is stated that suspension order was imposed on 21/03/2015. The allegation against the petitioner is that the petitioner failed to publish text books in Malayalam language which are intended to be distributed to the colleges.

2. It is submitted by the learned Standing counsel for the University that even though several reminders were issued to the petitioner, the petitioner failed to adhere to the time schedule given for publication of the text books. This Court cannot interfere with the suspension order.

3. Considering the facts and circumstances, I am of the view that if the entire disciplinary proceedings

could not be completed on or before 20/05/2015, the petitioner shall be reinstated in service with effect from 21/05/2015 onwards subject to the outcome of the disciplinary proceedings. The petitioner shall also co-operate with the enquiry. All other contentions in the writ petition are left open.
